



Trade Qualifier

Application Guide

For experienced tradespeople who have not completed an Ontario apprenticeship but have equivalent qualifications or experience in their trade and want to obtain an Ontario Certificate of Qualification.

WHO CAN APPLY

The Trade Qualifier application process is for experienced tradespeople who have not completed an Ontario apprenticeship but have equivalent qualifications or experience in their trade and want to obtain an Ontario Certificate of Qualification in the trade.

To become certified in a trade as a Trade Qualifier, applicants must go through a Trade Equivalency Assessment to have their trade qualifications and experience assessed against the trade's apprenticeship training standard to determine if it is equivalent to a completed apprentice.

You can apply through this process if:

- **A Certificate of Qualification is available in your trade.** See [Appendix A](#) for a list of trades in which a Certificate of Qualification can be issued. For all other trades, the highest level of certification is a Certificate of Apprenticeship obtainable only by completing an apprenticeship. For more information, [contact your local Employment Ontario apprenticeship office](#).
- **You do not hold an Ontario Certificate of Apprenticeship** (i.e., have not completed an Ontario apprenticeship) for the same trade. If you have already completed an apprenticeship, you can [apply to take the certifying exam for your trade](#).

- You do **not** hold a recognized trade certificate issued in another Canadian province or territory in the same trade. If you have been certified or licensed in a matched trade in another province or territory, you can [apply directly for an Ontario Certificate of Qualification](#).

If you do not qualify:

If you do not meet the requirements through the Trade Qualifier process, you may consider [becoming registered as an apprentice](#). Apprenticeship can be a great option even if you have significant trade experience as you can receive advanced standing in the program, beginning with hours and skills already credited towards completion.

For [compulsory trades](#), apprenticeship allows you to legally work in your trade while you gain additional experience and/or references to verify your work experience. If you have questions or require additional support, email assessments@skilledtradesontario.ca.

Note to active apprentices:

If you are a registered apprentice in Ontario or another Canadian province or territory, please note that there is no guarantee that your Trade Qualifier application will be approved and your application could impact your relationship with your employer/sponsor, and for certain trades, could affect your ability to work in the trade.

[Contact your local Employment Ontario apprenticeship office](#) to speak with an Employment and Training Consultant about your apprenticeship before proceeding with your application.

WHAT QUALIFIED APPLICANTS NEED TO INCLUDE

To be assessed under this process, you must provide:

1. Evidence of trade experience and skills
2. Identification

1. Evidence of Trade Experience and Skills

You must provide sufficient and verifiable evidence that you have:

- **Competency** in the skills of the trade, as defined by its [Training Standard](#), and
- **Experience** in the trade that is at least equal to the required or recommended minimum training time (see [Appendix A](#) for the hours required for each trade and [Appendix B](#) for a list of recognized hour credits between related trades).

Skills and experience requirements vary by trade and the nature of your trade experience. For the requirements for each trade, see [Appendix A: Trade-Specific Requirements](#).

You must submit one or more work experience verifications from references who can speak to your work experience in the trade. You must provide as many work experience verifications as needed to prove you have the required trade competency and hours of experience.

Work experience verifications must be provided in one of the following two ways: •

[Work Experience Verification Form](#), or

- Written letter, including company name and phone number, reference's name, job title, email address and phone number and a detailed description for each position you worked.

References must provide details for each position and/or project worked, including:

- Start and end dates and total number of months and hours worked, and
- Detailed descriptions of the tasks performed with specific examples to provide context.

If you are applying with employment experience, work experience verifications must be provided by a supervisor or manager who has trade knowledge (preferably a certified journey person) and who has direct knowledge of your work experience and trade competency.

If you are applying with self-employment experience, work experience verifications must be provided by other trades businesses that have used your services confirming your trade experience and competency. You will also need to provide the following additional documentation:

- Detailed resume of your previous trade experience, including:
 - Start and end dates and total number of months and hours worked for each job/project,
 - Detailed description of the tasks performed with specific examples to provide context.
- Supporting documents to prove your business exists (e.g., business number) and show the type of work performed (e.g., contracts, customer, and supplier invoices).

Notes re: Work Experience Verifications:

- **Work experience must be in the practice of a trade.** Experience must show time spent practicing the trade, rather than as a supervisor or manager, or time spent in school.
- **Verifications must be written by the references and not by the applicant or a third party.** Verifications must be in a language the reference is fluent in and then translated to either English or French (if needed) by a member of a [recognized Canadian association of translators](#).
- **If you hold a Canadian Forces Certificate of Military Achievement** with a Qualification Level 5 (QL5) or Developmental Period 2 (DP2) in one of nine matched trades, you do not need to

provide work experience verifications or pay assessment fee. You must include a copy of your Member's Personnel Record Resume (MPRR) as part of your application to skip steps 3 and 4 below. Once your trade qualification is verified, you will be approved to take the matched trade's certifying examination. For trade matches, see [Canadian Forces page of the website](#).

- **If you cannot provide evidence of work experience and demonstrated skills in your trade** because you are a refugee, refugee claimant, or immigrant from a war-torn area or region impacted by natural disaster, you may be eligible for exemptions from certain requirements. For more information, email assessments@skilledtradesontario.ca.

Note re: evidence:

While not required, you can provide additional documentation to help prove your trade experience. This could include providing copies of government-issued licenses, business registration or employment documents, technical training certificates, trade school transcripts, and other, additional verifications of your trade experience by certified journeypersons in your trade.

2. Identification

You must submit a legible copy of a recognized, government-issued photo identification with your application (at least one piece of identification).

What is acceptable identification?

Valid, original identification must be issued by a national, federal, provincial, territorial, or state government authority. Photocopies and expired documents are not acceptable. Identification must include your legal name, date of birth, photo, and signature. If not in English or French, identification must be translated by a valid member of a [recognized Canadian association of translators](#).

The following documents are acceptable forms of identification (if legal name, date of birth, photo and signature are displayed):

- Passport (Canadian or international)
- Canadian Citizenship Card
- Secure Certificate of Indian Status Card
- Canadian provincial or territorial driver's license or identification card
- Canadian immigration documents (issued by an Immigration, Refugees and Citizenship Canada or Canada Border Services Agency office, Case Processing Centre, or Canadian visa office) including:
 - Permanent Resident Card (PRC)
 - Landing (Form 1000)
 - Record of Visitor Record (IMM 1442)
 - Temporary Resident's Permit (IMM 1442)

- Confirmation of PR (Form IMM 5292)
- Student Authorization (IMM 1442)
- Employment Authorization (IMM 1442)
- Report Pursuant to Immigration Act (IMM 1442)
- Single Journey Travel Document (SJTD) for Resettlement to Canada (IMM 5485)

How to apply

If you meet the skill and experience requirements for your trade and want to apply for a Trade Equivalency Assessment for that trade, complete the following steps:

Step 1: Confirm you meet the requirements and prepare your supporting documents

Ensure you have the minimum required hours of hands-on work experience and competency in the trade you are applying for and that you can provide all the required documentation.

To be approved, you must provide adequate proof that you have the required hours of experience and demonstrated skills in your trade, to equal or exceed the on-the-job training standard required to complete an apprenticeship in Ontario.

Make sure you have all the required documentation before submitting, including:

- **Evidence of trade experience and skills** — see [What Qualified Applicants Need to Include](#) (above) and [Appendix A: Trade Requirements](#) (below) for the requirements for your trade, and
- **Identification** (copy of photo identification) — see [Identification Requirements](#) (above).

Incomplete applications will not be accepted.

Step 2: Submit your completed application to Skilled Trades Ontario

Submit your application with the required documentation in one of two ways:

- **Complete the [Application Form](#)** and submit it by email to: assessments@skilledtradesontario.ca or
- **Apply online on the Skilled Trades Ontario Portal (skilledtradesontario.ca)**. Select 'Log in' (top right), then under 'Certification', select 'Sign-in to existing portal account' or 'Create new portal account', then select 'New application', and then 'Trade Equivalency Assessment'.

On receipt of your application, Skilled Trades Ontario will verify that it is complete. If it is determined to be complete, you will need to make your assessment fee payment.

Step 3: Make your assessment fee payment

The Trade Equivalency Assessment fee is \$265.55 (HST included). You can pay by credit card (online or by phone), or by certified cheque or money order (by mail):

- **Online on the Skilled Trades Ontario Portal (skilledtradesontario.ca):** Select 'Log in' (top right), then under 'Certification', select either 'Sign-in to existing portal account' or 'Create new portal account' if you do not already have an account, then select 'Fees' (top of the page).

When paying by credit card, your fee payment cannot be processed until after your application has first been reviewed and determined to be complete and ready for assessment. You can check the status of your application [online](#) or by calling us, so you know when to make payment.

Step 4: Skilled Trades Ontario conducts its assessment

An assessment of your skills and experience will be conducted based on the documents you submit with your application. **Assessments may also include additional verifications, including:**

- **Contacting your reference(s)** – Skilled Trades Ontario or a third-party may conduct telephone interviews with your reference(s). Any questions about these background checks should be directed to Skilled Trades Ontario. Three attempts will be made to contact references. Failure to make contact may result in exclusion of the reference from your assessment.
- **Requiring your participation in one or more interviews** – Skilled Trades Ontario may conduct inperson or telephone interviews with you regarding your application. If an interview is required, Skilled Trades Ontario will attempt to accommodate your schedule and language needs, but failure to participate in a required interview will result in your application being denied.

Step 5: You will be notified of the assessment result

Once your assessment is complete, you will be notified of the result and your next steps.

If your trade is compulsory, you will not be permitted to work in your trade until you either: pass the certifying examination; are approved under this process; or become a registered apprentice.

Requirement:

You must submit evidence of knowledge of the Canadian Electrical Code (CEC), including either:

- **Option A:** Proof of legal work experience in an electrician trade in Canada (for example, as an apprentice or working under an exemption). Submit evidence of trade experience with your application that clearly describes using/applying the CEC.
- **Option B:** Proof of completion of a Canadian Electrical Code course or program from a recognized Canadian training institution that:
 - provides an understanding of, and ability to apply, the latest requirements of the CEC,
 - is a minimum of 12 hours focused on the CEC, and
 - is delivered in-person or online by a recognized training Canadian institution including a Canadian College of Applied Arts and Technology, Private Career College, or other organization such as the Canadian Standards Association (CSA).

If you have already completed training that meets the above criteria, submit proof of completion of training with your application and Skilled Trades Ontario will determine if it is acceptable.

If you have not completed training that meets the above criteria, you must identify an acceptable training course or program. Several Ontario training providers offer training programs that meet these requirements. If you have identified a course that meets the criteria, you can request a review of the training before you enroll by emailing a detailed description of the training to:

Appendix D: Additional Requirements for Hoisting Engineer Trades

Requirement:

You must submit a completed [Declaration of Experience form](#) with your initial application, indicating your hours of experience on various crane types. Applications submitted without a complete form will not be accepted.

After your initial assessment, you will need to pass a three-part Demonstration of Skills Test in the order outlined:

1. Hand Signal Test (confirmation of knowledge of safety signals for crane operation)
2. Load Chart Test (confirmation of knowledge of maximum safe loads)
3. Demonstration on Equipment Test (practical demonstration of safety, care, operation of equipment)

You must pass all three (3) tests as part of your hoisting trade qualifier application. It is recommended that you complete the three (3) tests prior to submitting your application to Skilled Trades Ontario (STO). Test Centres will provide results to STO prior to the trade qualifier assessment decision being rendered.

All three (3) tests must be scheduled in the order outlined above and can be taken at any test center across any number of testing centers (you don't have to take all the tests at the same location).

Test Limits

Tests that need to be retaken must be taken at least 30 full days after the final attempt. If you have schedule tests in sequence on a single day, if you fail any test into the lead up to the third test, all testing will stop at the point of the failed test and will have to be scheduled at a later date in accordance with this requirement.

If you fail any of the DOST parts (1, 2, and/or 3) on more than two occasions—regardless of whether these attempts occur at the same or different testing centres—you will be required to wait one full calendar year prior to re-attempting the DOST.

- **Welding (456A)**

Requirement:

You must submit a valid certificate indicating you have completed the welder practical assessment with a recognized testing centre on the following six welding processes:

1. Shielded Metal Arc Welding (SMAW - 3G)
2. Shielded Metal Arc Welding (SMAW - 3F & 4G)
3. Gas Metal Arc Welding (GMAW - 1G)
4. Gas Tungsten Arc Welding (GTAW - 2G)
5. Flux Cored Arc Welding (FCAW - 3F & 4G)
6. Oxy-Fuel Cutting

You must complete the welder practical assessment at a designated testing centre and submit proof of completion to Skilled Trades Ontario with your initial application.

You must schedule your assessment with one of eleven testing centres in Ontario (fees vary).

To meet this requirement, you must complete a training program and obtain certification from a food handler training and certification program that is recognized by the Ontario Ministry of Health and Long-Term Care (MOHLTC), including:

- Programs recognized by the MOHLTC as equivalent to the training and certification offered by local public health units.
- Programs offered by or on behalf of Ontario public health units that qualify for a Provincial Food Handler Certification Card.
